

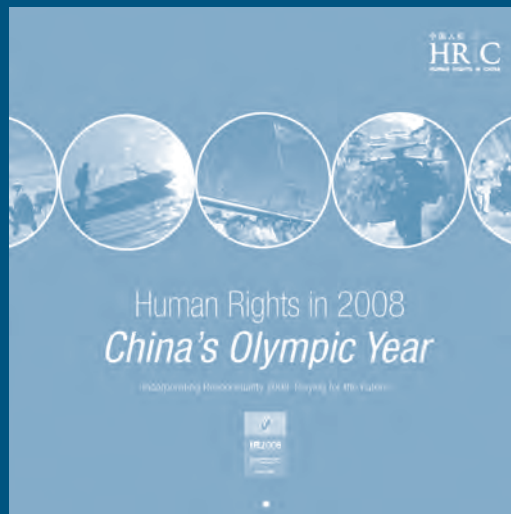
# CONTRIBUTE TO CHANGE

## 5. For your reference:

**Tax-deductible information:** HRIC is a 501(c)(3) organization registered in the United States. Your gift is tax-deductible to the extent allowed by law. The Internal Revenue Service (IRS) requires HRIC to inform donors that the amount of the donor's contribution that is deductible for federal income tax purposes is limited to the excess of any money contributed by the donor over the value of goods or services provided by HRIC. The value of a one year subscription to *China Rights Forum* is \$38. The value of one HRIC *Human Rights in 2008: China's Olympic Year* calendar is \$10.
